# DEAR FRIENDS AND COLLEAGUES,

We are pleased to present the Annual Report of the Maryland Legal Services Corporation (MLSC) for the fiscal year ending June 30, 2015. Since the creation of MLSC and the Interest on Lawyer Trust Accounts (IOLTA) Program in 1982, we have made grants exceeding \$200 million to provide civil legal assistance to low-income Marylanders in more than two million legal matters.

Fiscal year 2015 marks the thirty-third year of MLSC's funding legal services to serve the ends of justice in our state. This year, we supported thirty-six nonprofit organizations throughout Maryland for the provision of critically needed legal assistance in compelling matters, including evictions, foreclosures, domestic violence, child custody, veterans benefits, employment discrimination, and other issues impacting the health and well-being of individuals, families and communities.

MLSC grantees reported serving close to 156,000 Marylanders in FY 15, benefiting more than 230,000 people in matters involving basic human needs such as shelter, safety and sustenance. Despite decreasing IOLTA revenue due to the continued near-zero interest rates, and lower than projected court filing fee surcharge revenue, MLSC has been able to maintain level operating grants to the providers, preserving stability in the legal aid delivery system. Additionally, MLSC benefited from lawsuit settlements by the U. S. Department of Justice with Bank of America and Citicorp, receiving \$1.4 million to be used for foreclosure prevention and community redevelopment legal services in the coming year.

Given the prospect of a rise in the Federal Funds target interest rate for the first time in close to a decade, MLSC will be working very actively to restore our IOLTA resources, as well as continue to explore ways to develop new funding mechanisms. We look to the continued support and assistance of our partners in the bar, courts, state government, financial institutions, law schools, and legal services programs in this mission.

We appreciate your dedication and support as we continue to work together to provide justice to all in Maryland.

# **HIGHLIGHTS OF 2015**

## **MLSC** Revenue

for grants is generated from the MLSC Fund, which is composed of three special funding sources: (1) Interest on Lawyer Trust Accounts (IOLTA) held by Maryland licensed lawyers; (2) a surcharge on certain Circuit and District Court filing fees; and (3) \$1,500,000 from the Abandoned Property Fund. The MLSC Fund Appropriation is set in the State's budget each year based on projected revenues. The appropriation sets an upper limit on the amount that can be spent but does not guarantee that the Fund will receive that amount.

- FY 2015 IOLTA income was \$1.9 million, down from \$2.2 from the prior year, due to banks further reducing interest rates.
- FY 2015 filing fee surcharge revenue was \$12.7 million, down from \$13.2 from the prior year, due to fewer court filings.
- **FY 2015 MLSC Fund total revenue was \$16.9 million**, short of the \$17.5 million appropriation by \$624,512, due to less IOLTA and filing fee surcharge revenue.

# MLSC Grant Obligations of \$16.2 Million

for FY 2015 included operating grants to 36 organizations, including one new grantee, five challenge grants, 20 one-time grants and a litigation fund for expenses of pro bono and reduced-fee attorneys. Funding also included MLSC's portion of the Judicare Family Law Project through a partnership with the Administrative Office of the Courts to serve low-income persons through reduced-fee services by private attorneys in contested family law cases.

# **Delivery Statistics**

Services to clients in FY 2015 decreased 3% from the prior year, with MLSC grantees opening 156,000 new cases and benefiting 230,000 individuals and families.


Family law services, about 36% of all cases, involved domestic violence, child custody, child support and other matters and benefited 76,000 people.

Help with foreclosures, evictions and other housing cases, which were 27% of cases, benefited 77,000 individuals and families.

Help with debt collection, bankruptcy and other consumer cases, which made up 12% of all cases, directly benefited 23,000 individuals and families.

The private bar handled 8,000 cases through MLSCfunded organizations. Pro bono attorneys gave 75,000 hours, valued at \$20 million in donated legal services.


The Judicare Project referred 1,200 Judicare cases to 400 reduced-fee attorneys that spent 24,000 hours of service, including 6,500 pro bono hours, valued at \$1.6 million, which benefited 2,800 individuals and families.

### Notable Achievements

With a Foundation Leadership Grant from the National Association of IOLTA Programs, MLSC collaborated with the Association of Baltimore Area Grantmakers to provide workshops and materials to educate the philanthropic community about the value of investing in civil legal aid to achieve their missions of alleviating poverty, securing income and family stability, ensuring health care, ending violence and building stronger communities. Topics, along with twopage funder briefs, included "Civil Legal Aid: Investing in Justice," "Supporting Justice for LGBTQ Marylanders," "Promoting Economic Security for Low-Wage Workers" and "Helping Vulnerable Immigrants Find Safety."

**Foreclosure Prevention** legal services for Maryland homeowners and tenants will be sustained thanks to one million dollars in grants from MLSC to nine nonprofit organizations. The funding was made possible from a portion of multi-billion dollar lawsuit settlements by the U.S. Department of Justice with Bank of America and Citicorp that were directed to funders of civil legal services throughout the country. The timing of these funds was critical with Maryland's foreclosure rate among the worst in the nation and the expiration of funding in 2015 from a three-year national mortgage settlement.

# MID-SHORE OLDER ADULTS TARGETED FOR LEGAL SERVICES

Recognizing that seniors represent a growing proportion of Eastern Shore residents, Mid-Shore Pro Bono (MSPB) started a monthly legal clinic to help draft legal instruments (wills, powers of attorney) as well as provide advice about abuse and neglect, adult guardianships, homeowner and consumer concerns, Social Security and pensions, nursing homes and assisted living programs. Executive Director Sandy Brown explained, "With too many con artists out there preying on seniors' insecurities, they can be reluctant to deal with necessary legal issues before it is too late."

# AWARD WINNERS

**The Arthur W. Machen, Jr. Award** was presented to **Lawrence D. Coppel**, a member of Gordon Feinblatt LLC, and chair of the firm's Bankruptcy and Restructuring Practice Group, who has demonstrated a deep commitment to pro bono legal services and to opening the courts to Maryland's indigent litigants through self-help bankruptcy and debtor assistance clinics for clients and professional development for volunteer lawyers.

The Benjamin L. Cardin Distinguished Service Award was presented to Pamela Cardullo Ortiz, director of the Access to Justice Department of the Administrative Office of the Courts, and to Maureen A. Sweeney, a member of the clinical faculty of the University of Maryland Francis King Carey School of Law. Ms. Ortiz has spent her 22-year legal career in public interest law, working tirelessly and creatively to move Maryland toward providing more complete access to civil legal services to low-income people. Ms. Sweeney started her 26-year legal career serving farmworkers and immigrants in nonprofit organizations and has focused her law school research and clinic work on deportation defense for asylum seekers, individuals with convictions, and victims of crime and on increasing access to legal representation for noncitizens.

The William L. Marbury Outstanding Advocate Award was presented to D. Crystal Mack, a legal advocate at the Women's Law Center for 11 years, who has provided zealous advocacy for victims of domestic violence in Carroll County and serves as a point person for anyone coming to the Courts seeking protection from abuse.

The Herbert S. Garten Public Citizen Award was given to Gore Brothers for its commitment to access to justice by providing discounted deposition and videotaping services and other support to many legal services providers.

MLSC honored Franklin D. Chambers, Jr., Ph.D. for his service as a member of the Board of Directors from 2011 to 2015.

# MARYLAND LEGAL AID HELPS CLIENT NAVIGATE SMALL CLAIMS COURT

When Vivian Swann came to the new District Court Self-Help Center in Upper Marlboro in Prince George's County, she had already filed a small claim against a termite company. After paying the company to rid her new home of termites, she later found extensive damage. Although Ms. Swann agreed to dismiss the suit when the company promised to pay her a reduced amount, the company failed to follow through. With the help of Maryland Legal Aid attorney Susan Gebhart, Ms. Swann left the Self-Help Center with the necessary court documents to file a motion to enforce the agreement. The company quickly sent her the payment due.

# GRANTEES

The Maryland Legal Services Corporation annually awards grants to nonprofit organizations that provide civil legal services to eligible persons. MLSC funding supplements other federal, state and private sources for civil legal assistance. In May 2015, MLSC approved for the coming year \$15,204,104 in unconditional operating grant awards to 35 organizations. Two organizations were awarded \$264,000 in "challenge grants." In addition, in partnership with the Administrative Office of the Courts, MLSC provided funding in the amount of \$1,993,560 for the continuation of the Judicare project, which pays reduced fees to private attorneys for contested family law representation. # PRO BONO ATTORNEY GETS BENEFITS FOR HOMELESS VETERAN

Mollie Wander, a pro bono attorney with the Homeless Persons Representation Project, helped a homeless Army veteran in Baltimore get a 100 percent disability rating for trauma he endured during his service, and he is now getting \$2,800 a month in VA benefits. Not only is the veteran no longer homeless, he was awarded at least \$78,000 in back benefits. "He has a daughter and he plans to help pay her college tuition,"Ms. Wander said.

After extensive and intense negotiations by her attorney, Ms. Lozada got sole custody of her children, and the father's visitation privileges were reduced.
