Dear Friends and Colleagues,

We are pleased to present the Annual Report of the Maryland Legal Services Corporation (MLSC) for the fiscal year ending June 30, 2013. Since the creation of MLSC and the Interest on Lawyer Trust Accounts (IOLTA) program in 1982, we have made grants of almost \$200 million to help provide civil legal assistance for low-income Marylanders in over two million legal matters.

This year MLSC completed thirty-one years of funding legal assistance and serving the ends of justice. We continued to support thirty-four nonprofit organizations throughout the state that provide critically needed legal assistance in matters such as foreclosure, eviction, elder care, domestic violence, child custody, employment, food stamps, veterans' benefits, and myriad issues impacting housing, health care, and other basic human needs. With the help of our coalitions, we achieved major successes in the 2013 Maryland General Assembly. Faced with the loss of increases in court filing fee surcharges that were enacted in 2010 and scheduled to end this year, we achieved a five-year extension, which prevented a catastrophic funding loss. Additionally, we gained a \$1 million annual increase in our allocation from the Abandoned Property Fund. Despite IOLTA rates remaining at historic lows, our legislative achievements helped to avoid cuts in grant funding for the coming year, improving the safety net for legal services for low-income Marylanders.

Fiscal Year 2013 saw an increase in client services despite an average reduction in grant funding of five percent, with grantees stretching resources to meet the continuing increase in demand for legal services. Over 168,000 people in all twenty-four Maryland jurisdictions, the highest number in the Corporation's history, received legal services from MLSC grantees. These services benefited approximately 252,000 individuals and families in our state.

As MLSC enters the next fiscal year, we are fortunate and grateful to have the support and dedication of our partners in the Judiciary, Maryland State Bar Association, Maryland Access to Justice Commission, legal services providers, and many others, working tirelessly to ensure a strong legal services delivery system. Through our ongoing collaborative efforts, we remain committed to ensuring meaningful access to justice for all.

Despite IOLTA rates remaining at historic lows, our legislative achievements helped to avoid cuts in grant funding for the coming year.

Highlights of 2013

MLSC Revenue

for grants is generated from the **MLSC Fund**, which is composed of three special funding sources: (1) Interest on Lawyer Trust Accounts (IOLTA) held by Maryland licensed lawyers; (2) a surcharge on certain Circuit and District Court filing fees; and (3) \$500,000 from the Abandoned Property Fund. The **MLSC Fund Appropriation** is set in the State's budget each year, and is based on projected revenues. However, this appropriation does not guarantee that the MLSC Fund will receive that amount.

- **FY 2013 IOLTA income was \$2.1 million** in Maryland, a 15% decrease from the prior year, due to a further decline in IOLTA interest rates.
- **FY 2013 filing fee surcharge revenue was \$13.1 million**, up slightly from \$12.8 in FY 2012.
- FY 2013 MLSC Fund revenue was \$15.7 million. Although the MLSC Fund appropriation was set at \$16.6 million, the Fund fell short by over \$827,000.
- **FY 2013 MLSC operating grant obligations of \$15 million** reflected a 5% cut in operating grants because of the Fund shortfall, while Judicare continued with level funding through our partnership with the Administrative Office of the Courts.

Victory in the Maryland Legislature

helped avert a funding crisis. Facing a 40% loss in revenue, MLSC and its coalition of advocates were successful in getting the Maryland General Assembly to extend court filing fee surcharges until 2018. Furthermore, many access to justice leaders, including the Maryland State Bar Association, Maryland Access to Justice Commission and legal services providers, secured an increase in the State Abandoned Property Fund allocation. Representing the first increase since this distribution was enacted in the 1980s, the allocation increased from \$500,000 to \$1,500,000 annually.

FY 2013 Grant Awards of \$16.6 Million

were approved by the MLSC Board. Operating grants of \$15,012,471 were awarded to 34 legal services providers, including a litigation fund for expenses of pro bono and reduced-fee attorneys and one challenge grant.

Awards in the amount of \$1,572,285 were made to seven grantees for the Judicare Family Law Project through a partnership with the Administrative Office of the Courts.

Delivery Statistics



Services to clients in FY 2013 increased 5% from the prior year, with MLSC grantees opening nearly 168,000 new cases, a record high, and benefiting almost 252,000 individuals and families.



Family cases, about one-third of all cases, involved domestic violence, child custody, child support and other matters and benefited nearly 80,000 people.



Foreclosures, evictions and other housing cases, also almost one-third of cases, benefited approximately 94,000 individuals and families.



Debt collection, bankruptcy and other consumer cases, which are one-fifth of all cases, directly benefited 23,000 individuals and families.



The private bar handled almost 8,000 cases through MLSCfunded organizations. Pro bono attorneys gave nearly 69,000 hours, representing almost \$19 million in donated legal services.



Helping to leverage pro bono, the Judicare Project referred about 1,000 Judicare cases to nearly 500 reduced-fee attorneys that provided 22,000 hours of service, including at least 2,000 pro bono hours, which benefited 2,700 individuals and families.



Moving from Nursing Home into Community

"Shirley" was thrilled to move into her new house in Baltimore County after nearly three years in a nursing facility with help from the Maryland Disability Law Center (MDLC). Shirley had a special voucher for nonelderly persons with disabilities who are transitioning from nursing homes to the community, but ran into obstacles finding the right place and location to meet her needs. MDLC's Sunshine Folk, a group of advocates with disabilities who were formerly institutionalized, and MDLC's housing lawyers helped Shirley get an extension of her voucher and a professional housing transition team, ensuring that her rights to reasonable accommodations were protected.

Unemployment Benefits Preserved with Help of Legal Advocate

Paris Cannon from Caroline County came to Maryland Legal Aid's Upper Shore office to get her unemployment benefits reinstated. She said, "I hope someone can help me because I can't do it on my own." Paris had been at her job for 3 years and was up for a promotion but was terminated after her employer alleged that she had confronted and threatened a co-worker. She and the co-worker did not get along, and the poor relationship escalated. Legal Aid's paralegal represented Paris at a contested telephone hearing before a hearing examiner. The hearing examiner reversed the denial of benefits when the employer could not prove gross misconduct. Legal Aid also helped her when the employer appealed, and the decision was affirmed by the Board of Appeals.

Annual Awards



Each year, the Corporation solicits nominations and presents awards to persons and organizations that have contributed significantly to the provision of legal services to the poor. MLSC held the Annual Awards Reception at the Lord Baltimore Hotel on December 9, 2013.



The **Arthur W. Machen, Jr. Award** was presented to **Manuel R. Geraldo**. Mr. Geraldo, of Prince George's County, has a long history of pro bono and public service volunteerism to ensure access to justice.

The **Benjamin L. Cardin Distinguished Service Award** was presented to **Carolyn S. Malinowski**, managing attorney at Maryland Volunteer Lawyers Service, and to **Barbara A. Samuels**, managing attorney of the American Civil Liberties Union of Maryland. Ms. Malinowski, practicing for over 20 years, provides day-to-day advocacy in adult guardianship court helping mostly frail, elderly clients. Ms. Samuels, the lead counsel in a public housing desegregation case that was recently resolved after 20 years, has spent her 30-year career in public interest law.

The William L. Marbury Outstanding Advocate Award was presented to Nancy F. Aiken, Ph.D., executive director of CHANA (Counseling, Help Line, and Aid Network for Abused Women) and **Angelique Green-**Manning, managing legal advocate of the House of Ruth Maryland, who have both dedicated many years to advocating for victims of domestic violence. Dr. Aiken oversees the Jewish community's response to domestic violence, including a network for pro bono legal services. Ms. Green-Manning provides the front-line response to victims in crisis and helps put clients at ease.



Tenant in Foreclosed House is Now Homeowner

Three years ago, Kenneth Brown's mother learned that her landlord was in foreclosure and that Fannie Mae wanted to evict her from her longtime Baltimore home. But through the Brown family's persistence, Public Justice Center's (PJC) legal advocacy, and the support of community organizing partners, Kenneth and his brother Berveyn were able to buy the home this year. Together, PJC and the Browns challenged multiple eviction attempts in court and demanded needed repairs. PJC community organizing partners also secured a meeting with Fannie Mae executives. The Browns avoided eviction and ultimately bought the house from Fannie Mae this year. After a hard fight, the house was theirs.

Grantees

The Maryland Legal Services Corporation annually awards grants to nonprofit organizations that provide civil legal services to eligible persons. MLSC funding supplements other federal, state and private sources for civil legal assistance. In May 2013, MLSC approved for the coming year \$14,808,557 in unconditional operating grant awards to 35 organizations, including one new grantee, and \$329,000 in challenge/matching grants to five organizations. In addition, in partnership with the Administrative Office of the Courts, MLSC approved funding in the amount of \$1,900,000, a 21% increase, for the continuation of the Judicare project, which pays reduced fees to private attorneys for contested family law representation. Judicare revenue includes \$200,000 for a supplemental fund administered by MLSC. More information about the grant process, application deadline and current grantees is available at www.mlsc.org.

Allegany Law Foundation, Inc.
